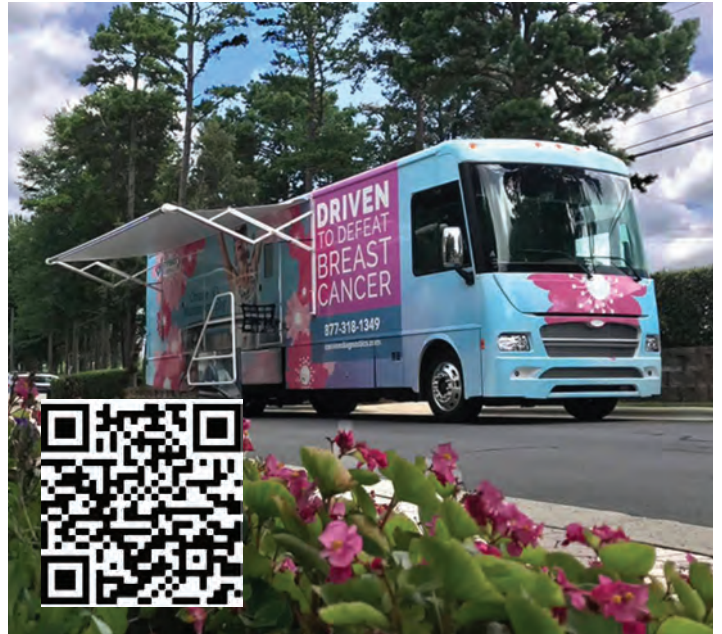

### Details and Eligibility

- If your staff are over 35-years-old and have not had a mammogram in the past year, they are eligible for a mammogram! (Ages 35-39 are eligible for 1 scan within those years, 40 and over eligible annually.)
- Invision will process everything through their Insurance so there is no cost to your staff!
- All images will be compared to previous year's images and read by a Breast Fellowship Board Certified Radiologist, and sent to the patients' primary care provider.
- Participating staff will need to bring their Insurance card and Driver's License to the appointment.

Appointments only take 15-minutes! To schedule an appointment at any of our branch locations, scan the QR code and enter the zip-code of the branch you would like to visit. Appointments can also be scheduled by phone by calling 877-318-1349. Please share with your staff.
